ON MOTION OF MR. GOTTSCHALL, SECOND OF MRS. O’LEARY, A UNANIMOUS VOTE TO AWARD THE ALTERNATE AND BASE BID TO NEW ENTERPRISE STONE AND LIME IN THE AMOUNT OF \$1,333,173.78 FOR THE 2018 REVISED ROAD WORK.

Administration

A) Restoring Hope Foundation – Waiver Request for Building Permit and Barricade Deposit Fees

Ms. Johnston informed the Board that a resident of Cumru Township was the recipient of Restoring Hope Foundation’s grant to remodel her home in consideration of her hardship. The charitable organization requested a waiver of building permit and other fees. Since this is a remodel, the fees are relatively low.

ON MOTION OF MR. MILLER, SECOND OF MR. GOTTSCHALL, A UNANIMOUS VOTE TO GRANT THE WAIVER OF BUILDING PERMIT FEES TO THE RESTORING HOPE FOUNDATION FOR THE PROJECT ON 511 BELAIR AVENUE.

Ms. Johnston explained to the Board that the recipient of the Restoring Hope Foundation award will need to place all of her personal possessions into a truck. The recipient is requesting that the Township allow her to leave the truck with all of the personal possessions on Township property. Ms. Johnston stated she will contact the solicitor to get his advice on the matter, regarding obtaining a hold harmless agreement. The Board of Commissioners concurred with that suggestion.
