Applicant prerequisites at the time of the filing deadline of July 7, 2021, include: Must be at least 18 years of age; have at least a high school diploma or equivalent General Education Certificate (GED); Fire Fighter 1; EVOC; Pump 1; Hazardous Materials Operations level; PADOH EMT B (current) or higher; Health Care Provider CPR/AED; Vehicle Rescue operations level. A valid class "B" commercial driver's license, with air brakes and tanker endorsement, is required upon application or by the end of 6 months of employment (training provided, if necessary), and must be maintained without suspension or revocation during the term of employment. In addition to successfully passing the written examination, any appointment to the position of Fire Fighter/Driver shall be conditioned upon the candidate successfully completing a CPAT physical fitness test, an oral examination, background investigation including voice stress analysis, criminal history clearance, PA child abuse history clearance, FBI identity history clearance, drug/alcohol screening, psychological examination, medical examination, and any other conditions established by the Township of Cumru. Satisfactory clearances must be maintained during the term of employment. The starting probationary salary is \$51,854.40 annually.

The written examination will be held at the Cumru Township Municipal Building, 1775 Welsh Road, lower level, Mohnton, PA, on Saturday, July 17, 2021, at 9:00 A.M. To be admitted to the testing facility, applicants must arrive no later than 8:45 A.M. and government issued photo identification will be required. No one will be permitted to enter the testing facility after 9:00 A.M. Directions to the testing location will be provided when the application is submitted.
